Booking and Storage conditions

1. We will do our best to accommodate all special and pitch requests, but cannot guarantee a specific pitch or location.
2. Caravanners are welcome to arrive and depart at any time.
If you expect to arrive before 8:00 a.m. or leave after 6:00 p.m. please inform us. Please move vehicles and caravans on the site with consideration for others.
If the site is muddy, we can tow for you.
To avoid danger to and from animals, all gates are closed from about 10:00 p.m. to 8:00 a.m.: please leave the gates as you find them.
3. If any accidents requiring medical attention or involving damage to property occur within the park, please inform the owners.
4. All caravans and vehicles are parked, stored and moved entirely at the owner's risk.
We accept no liability for loss or damage to property, or to injury to any person or animal.
5. Storage charges are levied every half-year at the end of the winter and summer storage seasons. Payment will be required within 60 days of this date.
If payment is outstanding at 90 days, we reserve the right to act in accordance with the law to dispose of the caravan or vehicle, in order to settle the outstanding account. Owners of caravans in storage are requested to inform us of any change of address. Please give us sensible notice if you want a caravan moved out of storage.
6. Owing to children on the site and farm animals & equipment moving through the farmyard, dogs on the site must be on a lead at all times. Vehicles moving through the farmyard should observe the 10 MPH maximum speed limit.
